- 1.) _____ The client agrees to pay the wedding videography fee of \$550.00
- 2.) _____ Wedding Package Includes (\$550.00) One DVD (4.7 GB or 2 hours)

 - c.) *1 Custom DVD label and 1 Custom DVD Box*
 - d.) *One Music Video*
 - e.) *Additional Copies at \$10.00 per copy*
 - f.) *All copies are on a DVD+R disc and may not play on all players*
- 3.) _____ The client agrees to pay a \$100.00 deposit before _____.
- 4.) _____ Video will be completed within three weeks of taping unless the client request additional content be added. At time of completion all remaining balances must be paid in full before final copy is released.
- 5.) _____ Franklin and Franklin Media has the rights to all raw footage captured and retains the right to use the final product along with all raw footage for advertisement purposes along with right to distribute on their website.
- 6.) _____ During the wedding Franklin and Franklin Media will take care to produce the most professional-highest quality video under their control; however, will not be held responsible for loss of coverage due to lack of lighting or blocked shots. Franklin and Franklin Media will not be held responsible for loss of content due to acts of God, power failure, malfunction of equipment, defective tape. If such acts happen the client will receive a full refund of balance paid including deposit.
- 7.) _____ Franklin and Franklin Media will not perform videography in the rain or other weather that may be harmful to video equipment. If event continues in weather which may be harmful to Franklin and Franklin Media's equipment then the deposit is non-refundable. Franklin and Franklin Media will work with the client if event is rescheduled or is moved to an adequate location. If weather prevents Franklin and Franklin Media from finishing their filming in the event of weather then the \$100 deposit is non-refundable, if wedding ceremony concludes and weather prevents filming during reception then all money must be paid (\$550.00) when final product is delivered. Franklin and Franklin Media retains full judgment to decide on filming when weather in question.

8.) _____ Franklin and Franklin Media is the sole videographer for the event and no other cameras may be used during the event. Personal cameras are allowed however, Franklin and Franklin Media is not responsible for blocked shots from the cameras.

9.) _____ Major Changes to the final product will only be made one week after the final copy draft has been delivered and at the charge of \$100. No changes will be made after the one week period is over and any products delivered during the time frame will not be altered. The client will have an opportunity to review the final product before distribution and if minor changes are wanted these will be made at no additional cost. If the client is unable to view the final product within one week or Franklin and Franklin Media does not hear back from Client after the final copy draft is sent then full payment is expected and Final Copies will be produced.

10.) _____ It is the responsibility of the client to secure video rights of the facility and Franklin and Franklin Media will abide by all rules of the facility and directions of the wedding coordinator. Franklin and Franklin Media is not responsible for lost shots due to these rules and the \$100 deposit is nonrefundable if video taping is not allowed to take place at the event facility.

11.) _____ The deposit fee is nonrefundable unless the event is cancelled by _____ or the above mentioned actions happen.
